How EFT Works

- ✓ The deduction will continue until Community Shares receives **written notice** to terminate the agreement.

How to get started

- ✓ Attach a voided check or savings deposit slip.
- ✓ You will receive an annual notification of any changes you would like to make to your contribution. If we do not hear from you at that time, your contribution will remain the same.
- ✓ Return the complete form to Community Shares (address below). The first automatic deduction will be on the 20th of the following month.
