THE COMMISSION HEREBY AFFIRMS that on March 18, 2011, the Commission unanimously approved for adoption the proposed amendments to Rule 1, Definitions, as initially published on February 8, 2011, with additional revisions to the definitions of DRUG, HARD and DRUG, PRESCRIPTION; and unanimously approved for adoption the proposed amendments to Rule 3, Qualifications for Original Appointment, as initially published on February 8, 2011, with additional revisions to § 2(C), Colorado Residency. Furthermore, the Commission hereby affirms that the following requirements for Rule Making were accomplished in full compliance with Commission Rule 2, Section 4.A.1-5:

- Posting a Notice of Public Hearing – Rule Making and the full text of the proposed amendments to the Rule 1 and Rule 3 at the Commission’s office and on the Commission’s web site from February 8, 2011 through March 4, 2011.
- Forwarding on February 8-9, 2011, the Notice of Public Hearing and the text of the proposed amendments to Rule 1 and to Rule 3, to the Manager of Safety, to the representatives of the collective bargaining agents for members of the Classified service, and to interested parties, and to the administration of the Fire and Police Departments with a request for posting throughout the departments.
- Holding a Public Hearing on March 4, 2011.
- Posting a Notice of Approved Revisions to the proposed amendments on March 29, 2011, and posting those revisions from March 29 – April 5, 2011.
- Forwarding on March 29, 2011, the Notice of Approved Revisions and the text of the approved revisions to the proposed amendments to Rule 1 and to Rule 3, to the Manager of Safety, to the representatives of the collective bargaining agents for members of the Classified service, and to interested parties, and to the administration of the Fire and Police Departments with a request for posting throughout the departments.

NOW THEREFORE, under the authority of Commission Rule 2, Section 4(A)(7), by this Notice of Adoption, the subject proposed amendments to Rule 1 and to Rule 3, with the approved revisions made subsequent to the Public Hearing, all as provided respectively in Attachment A and Attachment B, are hereby adopted to become **effective this 15th day of April, 2011.**
