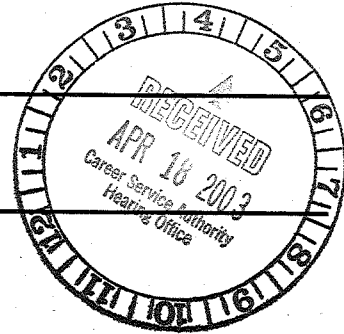


THIS MATTER has come before the Career Service Board on April 3, 2003. A record of the final vote concerning this decision is contained in the public minutes or records of this date.


