A BILL

For an ordinance authorizing the Mayor and other proper officials to enter into a grant agreement with the United States of America for a "Community Development Block Grant FY2009" program, a "HOME FY2009" program, and a "HOPWA FY2009" program, and the funding therefor.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The Mayor or his lawful successor and other proper officials of the City and County of Denver, in its behalf, are hereby authorized and empowered to enter into a grant with the United States of America, for a "Community Development Block Grant FY2009" Program, a "HOME FY2009" program, and a "HOPWA FY2009" program according to the facts and figures contained in the document filed with the City Clerk, Filing No. 09-0482.

Section 2. The Mayor, his successor in office, or his duly authorized representatives, and other officials of the City are hereby authorized and directed to do all things required to be done in order to obtain payments under the Grant, including, but not limited to, filing requests for payments, contracting with persons and organizations in order to carry out the provisions of the Grant, filing reports and keeping records relating to fiscal and evaluation matters, and forwarding other materials to the United States of America.

Section 3. The payments made by the United States of America to the City pursuant to and under the Grant shall be deposited into the Treasury of the City and credited to Special Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 4. The period for expenditure of said funds begins January 1, 2009. Funding is authorized as follows, to be expended by the Director of Economic Development based upon a letter of intent dated May 1, 2009 from the U. S. Department of Housing and Urban Development:
