14 Section 1; and

15 **WHEREAS**, the City Clerk Filing Number transcribed at Section 1 of Ordinance No. 309,
16 Series 2009, should be File No. 08-575-A; and

17 **WHEREAS**, the City has duly reviewed the proposed ordinance;

18 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
19 **OF DENVER:**

20 **Section 1.** The City Clerk Filing Number for Ordinance No. 309, Series 2009, approving a
21 proposed agreement between the City and County of Denver and Reilly Johnson Architecture,
22 should be corrected to read File No. 08-575-A. This number will replace the File No. 08-545-A
23 that was transcribed on the Bill for ordinance filed May 14, 2009 as the Council Bill No. 286 and
24 enacted as Ordinance No. 309, Series 2009, published June 5, 2009.
