A BILL

For an ordinance establishing new funds in the Gateway Impact Fees Special Trust Funds, authorizing the transfer of cash from various Gateway Special Trust Funds to the Capital Improvements Fund and making an appropriation in the Capital Improvements Fund.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. For the purpose of accepting monies from Gateway Regional Metropolitan District and Denver High Point at DIA Metropolitan District, there is hereby established in the Special Trust Fund, Accounting Number 56000, the funds indicated in the following tabulation:

Monies received from Gateway Regional Metropolitan District and Denver High Point at DIA and held in the Unapportioned Account will be deposited into the appropriate newly-created Fund upon passage of this bill.

Section 2. From the Gateway Impact Fees Special Trust Funds there is hereby authorized the transfer of cash to the Capital Improvements Fund, Auditor's No. 31000, in the amounts set forth in the following tabulation:
