A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the Casey Family Programs concerning the "Casey Child Welfare Initiative FY09" program and the funding therefor.

WHEREAS, by authority of Ordinance 312, Series of 2008, the City entered into a contractual agreement with the Casey Family Programs in support of the Child Welfare Initiative; and

WHEREAS, Casey Family Programs has tendered an amendment to the City providing second year funding for said program; and

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, between the Casey Family Programs and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 08-499-A, be and hereby is approved in all respects.

Section 2. The Mayor or his lawful successor and other proper officials of the City and County of Denver, in its behalf, are hereby authorized and directed to execute said Grant Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized and directed to attest and impress the official seal of the City and County of Denver on the Grant Agreement.

Section 3. The Mayor, his successor in office, or his duly authorized representatives, and other officials of the City are hereby authorized and directed to do all things required to be done in order to obtain payments under the Grant Agreement, including, but not limited to, filing requests for payments, contracting with persons and organizations in order to carry out the provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and evaluation matters, and forwarding other materials to the State of Colorado.

Section 4. The payments made by the Casey Family Programs the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to

1 Special Fund No. 13000, which is set forth and described in Section 20-18 of the Revised
2 Municipal Code of the City and County of Denver.

4 Section 5. That it be and is hereby found and determined that the budget summary of said
5 "Casey Child Welfare Initiative FY09" Program, Accounting Number 13601-5511101-H4010, is
6 as follows, to be expended by the Manager of Human Services.

7 Casey Family Programs \$450,000

8 Authorization for expenditure of said funds following execution of said grant will cover the
9 period from January 1, 2009 to December 31, 2009.

10 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
11 and directed to make such book and record entries and to do such other things as may be
12 necessary to accomplish the purposes of this Ordinance.
