A B I L L

For an ordinance approving and providing for the execution of a proposed contract between the City and County of Denver and the State of Colorado concerning the "Neighborhood Stabilization - State" program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Contract;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Contract, under CFDA No. 14.228, between the State of Colorado and the City and County of Denver, which is identified as Contract Encumbrance No. HONSP09310, a copy of which is duly filed with the City Clerk, Filing No. 09-1080, be and hereby is approved in all respects.

Section 2. The Mayor or his lawful successor and other proper officials of the City and County of Denver, in its behalf, are hereby authorized and directed to execute said Contract and the Clerk and Recorder of the City and County of Denver is hereby authorized and directed to attest and impress the official seal of the City and County of Denver on the Contract.

Section 3. The Mayor, his successor in office, or his duly authorized representatives, and other officials of the City are hereby authorized and directed to do all things required to be done in order to obtain payments under the Contract, including, but not limited to, filing requests for payments, contracting with persons and organizations in order to carry out the provisions of the Contract, filing reports and keeping records relating to fiscal and evaluation matters, and forwarding other materials to the State of Colorado.

Section 4. The payments made by the State of Colorado to the City pursuant to and under the Contract shall be deposited into the Treasury of the City and credited to Special Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

6 period from October 1, 2009 to March 10, 2013.

8 and directed to make such book and record entries and to do such other things as may be
9 necessary to accomplish the purposes of this Ordinance.
