A RESOLUTION

Laying out, opening and establishing a portion of a public alley, lying north of 1st Avenue between Monroe Street and Garfield Street.

WHEREAS, the Manager of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity require the laying out, opening and establishing as a public alley designated as part of the system of thoroughfares of the municipality that portion of real property hereinafter more particularly described, and, subject to approval by resolution has laid out, opened and established the same as a public alley;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described portion of real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

A tract of land lying in Lots 3, 4, 5 and 6, Block 6, Burlington Capitol Hill Addition, being a part of the Southeast Quarter of Section 12, Township 4 South, Range 68 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado.

Beginning at the southeast corner of said Lot 6, Block 6, Burlington Capitol Hill Addition; thence N89°49'47"W, along the southerly line of said Lot 6, a distance of 0.50 feet; thence N00°00'52"W, along a line that is 0.50 feet west of and parallel with the easterly line of said Lots 3, 4, 5 and 6, a distance of 99.97 feet to the northerly line of said Lot 3, Block 6; thence S89°47'10"E along said northerly line of Lot 3, a distance of 0.50 feet to said easterly line of Lot 3; thence S00°00'52"E along said easterly line of Lots 3, 4, 5 and 6, a distance of 99.96 feet to the Point of Beginning;

Containing 50 square feet more or less.

be and the same is hereby approved and said real property is hereby laid out and established and declared laid out, opened and established as a public alley.

Section 2. That the real property described in Section 1 hereof shall henceforth be a public alley.
