A RESOLUTION

**Laying out, opening and establishing a parcel of land for right-of-way purposes as 29<sup>th</sup> Avenue, at 29<sup>th</sup> Avenue and Marion Street.**

**WHEREAS**, the Manager of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity require the laying out, opening and establishing as a public street designated as part of the system of thoroughfares of the municipality those portions of real property hereinafter more particularly described, and, subject to approval by resolution has laid out, opened and established the same as a public street;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** That the action of the Manager of Public Works in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described portions of real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

**A parcel of land located in the Southwest 1/4 of Section 26, Township 3 South, Range 68 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado.**

**A Treasurers Deed conveyed to the City & County of Denver, recorded on the 18th of May 1984 in Book 3101 Page 389 in the City and County of Denver Clerk & Records Office being more particularly described as follows:**

**L 16 BLK 1 A B CASES ADD (COMONLY KNOWN AS: 1201 E 29<sup>TH</sup> AV APPROX)**

be and the same is hereby approved and said portions of real property are hereby laid out and established and declared laid out, opened and established as 29<sup>th</sup> Avenue.

**Section 2.** That the real property described in Section 1 hereof shall henceforth be known as 29<sup>th</sup> Avenue.
