A RESOLUTION

Laying out, opening and establishing a parcel of land for right-of-way purposes as West Iliff Avenue, at West Iliff Avenue and South Delaware Street.

WHEREAS, the Manager of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity require the laying out, opening and establishing as a public street designated as part of the system of thoroughfares of the municipality those portions of real property hereinafter more particularly described, and, subject to approval by resolution has laid out, opened and established the same as a public street;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described portions of real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

A parcel of land located in the Southwest 1/4 of Section 27, Township 4 South, Range 68 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado.

A Quit Claim Deed conveyed to the City & County of Denver, recorded on the 10th of January 1977 in Book 1373 Page 579 in the City and County of Denver Clerk & Records Office being more particularly described as follows:

That part of Lot 1, Block 5, Breenlow Subdivision of South Denver, described as follows: Beginning at the northwest corner of Lot 1; thence southerly on the west line of said Lot a distance of 5 feet; thence northeasterly a distance of 7.07 feet, more or less, to a point on the north line of said lot 1, that is 5.0 feet east of the northwest corner thereof; thence westerly on the said north line to the point of beginning.

be and the same is hereby approved and said portions of real property are hereby laid out and established and declared laid out, opened and established as West Iliff Avenue.

Section 2. That the real property described in Section 1 hereof shall henceforth be known as West Iliff Avenue.
