9 For an ordinance approving and providing for the execution of a proposed contract
10 between the City and County of Denver and the State of Colorado concerning the
11 "Neighborhood Stabilization - State" program and the funding therefor.

13 WHEREAS, the City and County of Denver has given due consideration to said proposed
14 Contract;

15 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
16 OF DENVER:

17 Section 1. The proposed Contract, under CFDA No. 14.228, between the State of Colorado
18 and the City and County of Denver, which is identified as Contract Encumbrance No.
19 HONSP09310, a copy of which is duly filed with the City Clerk, Filing No. 09-1080, be and
20 hereby is approved in all respects.

21 Section 2. The Mayor or his lawful successor and other proper officials of the City and
22 County of Denver, in its behalf, are hereby authorized and directed to execute said Contract and
23 the Clerk and Recorder of the City and County of Denver is hereby authorized and directed to
24 attest and impress the official seal of the City and County of Denver on the Contract.

25 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
26 other officials of the City are hereby authorized and directed to do all things required to be done
27 in order to obtain payments under the Contract, including, but not limited to, filing requests for
28 payments, contracting with persons and organizations in order to carry out the provisions of the
29 Contract, filing reports and keeping records relating to fiscal and evaluation matters, and
30 forwarding other materials to the State of Colorado.

31 Section 4. The payments made by the State of Colorado to the City pursuant to and under
32 the Contract shall be deposited into the Treasury of the City and credited to Special Fund
33 No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of
34 the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
2 "Neighborhood Stabilization - State" program, Accounting No. 16011-0145101-M2194, is as
3 follows, to be expended by the Director of Economic Development:

4 State of Colorado \$3,620,176
5 Authorization for expenditure of said funds following execution of said contract will cover the
6 period from October 1, 2009 to March 10, 2013.

7 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
8 and directed to make such book and record entries and to do such other things as may be
9 necessary to accomplish the purposes of this Ordinance.
