6 **for an ordinance amending the classification and pay plan for employees in the**
7 **Career Service and for certain employees not in the Career Service.**

9 **WHEREAS**, pursuant to 9.1.1 (C) and (D) of the Charter and Article I of Chapter 18, D.R.M.C.,
10 the Career Service Authority has recommended to the City Council an amendment to the classification
11 and pay plan governing the compensation of employees in the career service and certain employees
12 not in the career service;

13 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
14 **DENVER:**

15 **Section 1.** That effective **October 18, 2009**, the classification and pay plan is hereby amended
16 by changing the pay grade associated with certain job titles to read as follows:

<u>Job Title</u>	<u>Old Pay Grade</u>	<u>New Pay Grade</u>
Deputy Manager of Aviation for Operations	818-A	819-A

19 **Section 2.** That effective **October 18, 2009**, the classification and pay plan is hereby amended
20 by changing the job title and pay grade associated with certain job titles, to read as follows:

<u>Old Job Title</u>	<u>New Job Title</u>	<u>Old Pay Grade</u>	<u>New Pay Grade</u>
Psychologist Team Leader	Psychologist Supervisor	814-O	815-O
Operations and Production Supervisor	Entertainment Production Coordinator	808-T	808-G

26 **Section 3.** That the foregoing amendments shall be reflected in the full classification and pay
27 plan kept and maintained in the office of the Clerk and Recorder, as reflected at Clerk Filing No. 09-
28 355-D, and at the Career Service Authority, and shall be available for public inspection both in person
