9 For an ordinance accepting funding from Arapahoe County for the
10 "Leetsdale/Mississippi Avenue Intersection Improvements" program and
11 authorizing expenditures therefor.

13 WHEREAS, Arapahoe County has allocated funding to the City and County of Denver for
14 the "Leetsdale/Mississippi Avenue Intersection Improvements" program;

15 NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
16 DENVER:

17 Section 1. The proposed special allocation of funds from Arapahoe County be and hereby is
18 accepted in all respects, in accordance with the document filed with the City Clerk, Filing No. 09-
19 823.

20 Section 2. The payments made by Arapahoe County as a special allocation of funds shall
21 be deposited into the Treasury of the City and County of Denver and credited to Grant Projects
22 Fund No. 38000 which is set forth and described in Section 20-18 of the Revised Municipal Code
23 of the City and County of Denver.

24 Section 3. Expenditures are hereby authorized from the Grant Projects Fund, Accounting
25 No. 38000, the amounts of money in the following tabulation:
