## **ORDER**

On March 12, 2020, the Mayor of the City and County of Denver declared a state of local disaster emergency pursuant to C.R.S. § 24-33.5-701, *et seq.*, due to the risk of spread of the COVID-19 virus. More than fifteen months later, the City and County of Denver remains under this local disaster declaration.

On April 16, 2021, the Colorado Department of Public Health and Environment ("CDPHE") issued PHO 20-38, implementing new requirements to mitigate the spread of COVID-19. On April 16, 2021, the Executive Director of the Denver Department of Public Health & Environment ("DDPHE") issued a public health order ("PHO") adopting CDPHE PHO 20-38.

On May 2, 2021, CDPHE issued an amended PHO 20-38 ("Amended PHO 20-38"). On May 14, 2021, CDPHE issued a Second Amended PHO 20-38. On May 15, 2021, DDPHE issued an amended order adopting the Second Amended PHO 20-38 with addition requirements.

On May 31, 2021, CDPHE issued a Third Amended PHO 20-38. On June 1, 2021, DDPHE issued an amended order adopting the Third Amended PHO 20-38.

On June 30, 2021, CDPHE issued a Fourth Amended PHO 20-38. On July 1, 2021, DDPHE issued an amended order adopting the Fourth Amended PHO 20-38.

On July 31, 2021, CDPHE issued a Fifth Amended PHO 20-38. On August 2, 2021, DDPHE issued an amended order adopting the Fifth Amended PHO 20-38.

On August 31, 2021, CDPHE issued a Sixth Amended PHO 20-38. On September 9, 2021, DDPHE issued an amended order adopting the Sixth Amended PHO 20-38.

On September 30, 2021, CDPHE issued a Seventh Amended PHO 20-38. On October 7, 2021, DDPHE issued an amended order adopting the Seventh Amended PHO 20-38.

On October 30, 2021, CDPHE issued an Eighth Amended PHO 20-38.

This order hereby rescinds and replaces the DDPHE PHO, dated October 7, 2021, and adopts the Eighth Amended PHO 20-38.

If not rescinded, superseded, or amended in writing by the Executive Director of DDPHE, this Order will be effective immediately and expire on December 2, 2021.
