### INFORMATION and INSTRUCTIONS:

Denver based non-profit organizations, including government agencies, are eligible for Regional tier memberships at a discount (i.e. Neighborhood tier rates) in order to enhance their current service programs through Denver Parks & Recreation's (DPR) Client Services discount program. Agencies based outside of Denver that serve clients in Denver are also eligible. A minimum purchase of five memberships is required. Memberships must be of same type. \*For organizations with multiple locations, only one enrollment form will be accepted.

A DPR membership includes access to drop-in gym, game rooms, indoor pools, weight rooms, as well as drop-in fitness and drop-in aquatics classes at the membership level chosen. An outdoor pool season pass is also included. **Activities that require a separate registration are available at an additional cost.**

The Organization Representative (Executive Director, Program Director/Manager, or site supervisor) must; submit this completed form directly to Recreation Administration for approval and processing, provide proof of non-profit or government status (i.e. 501c3 or government tax exemption certificate), and serve as the sole point of contact for enrollment related confirmation and communication.

All group membership requests must be approved by the Deputy Manager of the DPR Recreation Division.

When presenting memberships at recreation centers, additional identification may be required.

**Memberships are non-refundable, non-transferrable, and cannot be combined with any other discount offer. Prices subject to change.**
